Dear Parent

I find that once again I need to remind parents of the school safety and security measures. Some parents continue to disregard our safety requests, which are put in place to ensure the safety and security of all our children. Merely because one is "running late" etc. is no excuse to disregard the very measures which ensure the safety of your own, and other, children. Children safety should be the concern of all at our school. Therefore, please note that the parking area outside the school needs to be used properly (i.e. drop and go), no double parking nor parking facing oncoming traffic etc. I have requested that law enforcement do regular visits to ensure proper traffic control. In addition, NO parent/adult is allowed to approach any Tafelberg learner on school property nor outside the school gate for any reason. Should you have an issue with a learner, please use the procedures explained at our parent meetings and at Orientation day. All parents/visitors, once entering the school grounds MUST report to the secretary immediately and wait in the foyer area to be helped. Should you enter the premises in a vehicle, the demarcated parking area MUST be used – no parking is allowed at the front entrance of the school. In addition, no parent is allowed to take photographs of learners on school property. Thank you for your co-operation.

2. School fees 2019

Tafelberg is a Section 21 fee-paying school, and the SA Schools Act thus places a duty on the SGB to collect such school fees from all parents as agreed upon at the parent AGM. The Budget and school fees for 2019 were voted on at the parent AGM on 7 November 2018. The Budget, school fee increase and certain policies (e.g. Code of Conduct, Uniform and Appearance, Language, Religious, and Admission policies among others) were tabled and accepted by a majority vote of parents at the AGM.



3. Learners leaving early

Please note that learners are not allowed to leave school early, according to WCED, unless there is a <u>valid</u> reason. The request, with the reason, must be forwarded to the school in good time. Furthermore, learners will only be released into the care of their parents. Should a family member / friend fetch the learner, the school needs to be notified in writing, and the person fetching the child must produce identification.

4. Hair / shaving

Parents are reminded to read the hair and appearance (specifically shaving) policy, and ensure that their child has read and understood the policy. Furthermore, it is the responsibility of the parents to ensure their child conforms to the said policies BEFORE they leave home in the morning. Infringement of the hair and appearance rules will result in afternoon DT. Boys not shaving will be issued with a razor (at R5 each) and will need to shave.

EXEMPTION OF PARENTS FROM THE PAYMENT OF SCHOOL FEES

Categories for purposes of exemption

- 3 (1) If annual school fees are determined in terms of section 39 of the Act, the following categories will be applicable for purposes of exemption of a parent from payment of such school fees
 - (a) ... full exemption
 - (b) ... partial exemption
 - (c) ... does not qualify for exemption
